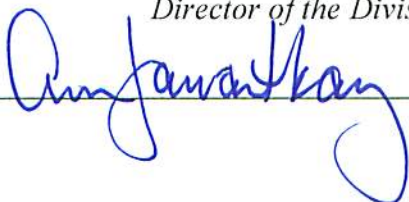

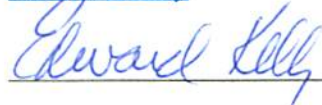

WHEREAS, the Annual Budget and Capital Budget for the Town of Hackettstown Municipal Utilities Authority for the fiscal year beginning, December 1, 2014 and ending, November 30, 2015 has been presented before the governing body of the Town of Hackettstown Municipal Utilities Authority at its open public meeting of September 9, 2014; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,960,000 , Total Appropriations, including any Accumulated Deficit if any, of \$1,958,506 and Total Unrestricted Net Assets utilized of \$0; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$2,400,000 and Total Unrestricted Net Assets planned to be utilized as funding thereof, of \$0; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the Town of Hackettstown Municipal Utilities Authority, at an open public meeting held on September 9, 2014 that the Annual Budget, including appended Supplemental Schedules, and the Capital Budget/Program of the Town of Hackettstown Municipal Utilities Authority for the fiscal year beginning, December 1, 2014 and ending, November 30, 2015 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the governing body of the Town of Hackettstown Municipal Utilities Authority will consider the Annual Budget and Capital Budget/Program for adoption on October 14, 2014.

1. Complete a brief statement on the **Town of Hackettstown Municipal Utilities Authority** proposed Annual Budget and make comparison to the current year's adopted budget. Explain significant increases or decreases, if any. **The Town of Hackettstown MUA proposes a Water Budget totaling \$1,958,506 for fiscal year 2015 compared to \$2,736,134 for fiscal year 2014. The proposed Budget represents a decrease of \$777,628 or 28.4%. The significant decrease is primarily due to capital projects being paid from Renewal & Replacement Reserves.**
2. Complete a brief statement on the impact the proposed Annual Budget will have on Anticipated Revenues, especially service charges and on the general purpose/component unit financial statements. Explain significant increases or decreases, if any. **The proposed Annual Water Budget for fiscal year 2015 is not anticipated to have any significant impact upon Water Service Charges during 2015.**
3. Describe the state of the local/regional economy and how it may impact the proposed Annual Budget, including the planned Capital Budget/Program. **Development has been impacted by the Highlands Act. Significant portions of the HMUA Serviced Area have been eliminated. Development has slowed in the remaining portions of the Service Area. However, additional Water Supplies and other Capital Budget items will have a significant impact upon the HMUA's Annual and Capital Budgets.**
4. Describe the reasons for utilizing Unrestricted Net Assets in the proposed Annual Budget, i.e. rate stabilization, debt service reduction, to balance the budget, etc. **No Unrestricted Net Assets are being utilized in the proposed Annual Budget.**
5. Identify any sources of funds transferred to the County/Municipality as a budget subsidy or a shared service. **Shared services include a Fuel Depot, sharing of paving costs and sharing of equipment.**
6. The proposed budget should not reflect an anticipated deficit. If there exists an accumulated deficit from prior years' budgets (and funding is included in the proposed budget as a result of a prior deficit) explain the funding plan to eliminate said deficit (NJSA 40A:5A-12). **The Budget includes an accumulated deficit from prior FY Audit Report. The amount has been funded in this Budget to eliminate the deficit.**
